



## California Supplemental Privacy Statement

### INTRODUCTION

If you are a California resident, you have rights under the California Consumer Privacy Act of 2018 (“CCPA”). This California Supplemental Privacy Statement:

- to the extent necessary, supplements the information provided about our collection, use, and sharing of Personal Information collected through Devon’s website in the [Devon Privacy Statement](#) and in website-specific privacy statements for specific Devon web pages;
- provides general information about our collection, use, and sharing of Personal Information related to California residents whether that data is generated through online or offline channels; and
- provides instructions on how to exercise rights granted to California residents under the CCPA.

### DATA COLLECTION AND USE

We may collect your Personal Information for various purposes, including, but not limited to, the purposes described below and as further described in the [Devon Privacy Statement](#).

***Responding to your request for information.*** When you contact us (online or offline) in connection with a request for information or to provide you with support, we collect information necessary to fulfill your request or to provide you with support and to be able to contact you. We may retain such information for administrative purposes, to defend our rights, or to manage our relationship with you.

***Administering our website.*** When entering our website, we will record information necessary to provide you with access, for the operation of the website, and for us to comply with security and legal requirements in relation to operating our website, such as passwords, IP address, and browser settings. We also collect information about your activities during your visit to personalize your website experience. More information about our use of Personal Information can be found in the Devon Privacy Statement.

The specific kinds of Personal Information that we may collect regarding California residents for the above purposes may include:

- Identifiers such as IP address and cookies;
- Biographical, demographic, and professional information (e.g. date of birth, age, gender, job title/position, marital status and dependent, spousal and other family information);
- Information regarding your nationality and country of residence that allows us to determine your eligibility under export control regulations to receive information about certain technologies;
- Contact details, such as your name, title, company/organization name, email address, telephone and fax numbers, and physical address;
- Division orders, leases, inquiries, public records, and other documents submitted by an individual or their representative or gathered by Devon while managing ownership interests and revenue distributions associated with an oil and gas property;
- Internet activity data (e.g. information about your devices, browsing actions and usage patterns that we obtain using cookies, web beacons and similar technologies; and
- Location data (e.g. data derived from your IP address, country and zip code) and the precise geolocation of your mobile device where we have provided notice and choice

As explained in the [Devon Privacy Statement](#), we may collect Personal Information directly from you, or automatically from your device.

Also, in connection with our processing, defense, or pursuit of legal and/or insurance claims involving California residents, we may obtain government-issued ID numbers and Tax ID numbers, such as U.S. Social Security numbers.

## DATA SHARING

We may share information about you with our subsidiaries, affiliates, joint venture partners, suppliers, and where appropriate, with selected partners.

As explained in the Devon Privacy Statement, we may also disclose your Personal Information that we collect to others described below, or otherwise, where we have your consent.

**Disclosure to service providers.** Devon contracts with other companies to provide services on our behalf, such as hosting websites, sending out information, and analyzing our website. We provide these companies with only those elements of Personal Information they need to deliver those services. These companies and their employees are expressly prohibited from using those Personal Information for any other purposes.

**Disclosures in connection with acquisitions or divestitures.** Circumstances may arise where for strategic or other business reasons Devon decides to buy, sell, merge or otherwise reorganize certain aspects of its business. Such a transaction may involve the disclosure of Personal Information to prospective or actual purchasers or receiving the same from sellers. Although it is Devon's practice to seek protection for information in these types of transactions, we cannot guarantee that any entity receiving such data from Devon in connection with one of these transactions will comply with all the terms of this Privacy Statement.

**Disclosure for other reasons.** We may disclose Personal Information if required to do so by law or in the good-faith belief that such action is necessary to comply with legal requirements or with legal process served on us, to protect and defend our rights or property, or in urgent circumstances to protect the personal safety of any individual.

## YOUR RIGHTS

In addition to the rights granted under the Devon Privacy Statement, as a California resident, you have the right to:

**Know your Personal Information:** You can request specific pieces of Personal Information, or information about the categories of Personal Information that Devon holds about you by submitting a request through our [Privacy Contact Form](#).

**Request Deletion of you Personal Information:** You can request the deletion of the Personal Information that Devon holds about you by submitting a request through our [Privacy Contact Form](#).

**Opt-Out of the Sale of Personal Information:** We do not sell your Personal Information. Therefore, we do not offer an opt-out to the sale of Personal Information.

**Non-discrimination:** If you choose to exercise any of these rights, we will not deny services to you or provide a different quality of services.
